#### **Background Information**

The Congress was attended by 1,600 delegates from 118 countries. ICC Chairman Marcus Wallenberg brought the 5th World Chambers Congress to a close and, in a special ceremony, handed over the hosting of the congress from Istanbul to Kuala Lumpur, where the biennial congress will take place in 2009. "Our memories of the event and this city will stay with us for many years to come," Mr Wallenberg told delegates assembled at the congress closing. "But, more importantly, the partnerships and connections made here will also continue long into the future. This is what the congress is all about: building the links that ultimately facilitate trade among nations."

Mr. Wallenberg also highlighted the multilateral trade declaration produced at the congress: to press harder for a global trade accord in the World Trade Organization's Doha round of trade negotiations. The statement was issued during this afternoon's plenary on threats to multilateralism and endorsed by the 1,600 delegates from 118 countries attending the congress.

"We are counting on you to redouble your efforts when you return home, to convince your government leaders to act swiftly to finalize an agreement in the Doha round of world trade talks," said Mr Wallenberg, who is also Chairman of the Swedish banking group SEB.

Rona Yircali, Chair of ICC's World Chambers Federation; Guy Sebban, ICC Secretary General; Rifaat Hisarciklioglu, President of the Union of Chambers and Commodity Exchanges of Turkey; Kadir Topbas, Mayor of the City of Istanbul; Halim Borhan, Mayor of the City of Kuala Lumpur and Yong Poh Kon, President of the Federation of Malaysian Manufacturers, accompanied Mr. Wallenberg on the stage.

Highlights from the three-day Congress also included:

- Opening statement by Turkish Prime Minister Revcep Tayyip Erdogan
- An address by former US Secretary of State Madeleine Albright
- An address by Mohammed Yunus, 2006 Nobel Peace Prize winner and founder of Grameen Bank, on microcredit and reducing world poverty

- Five plenary sessions on threats to multilateralism, managing global risks, supporting SME development, securing the future of energy and chambers and migration
- A series of 23 workshops covered a wide range of topics, including customer service, chamber branding, leadership versus management, intellectual property, IT and ebusiness for chambers and empowering businesswomen
- A Bosphorus Strait cruise and banquet dinner at the Ciragan Palace
- A dinner at the Rahmi Koc Museum
- The 2007 World Chambers Competition for the most innovative projects from chambers of commerce

More than 55 dossiers from 30 countries were received for the 2005 competition. Entries came not only from developed countries but also from developing and least developed countries.

Previous finalists and winners of this increasingly popular event have experienced a significant impact on their local and national profile and on their influence due to the recognition received for their participating projects.

2007 competition finalists will present their dossiers to the international judging panel as part of the 5th World Chambers Congress, held 4-6 July 2007, in Istanbul, Turkey.

Through the World Chambers Competition, WCF continues to fulfill its mission, to encourage chamber excellence and dynamism while fostering information exchange and business development.

Several new categories have been included for the 2007 edition of the competition. Each competition incorporates new categories to provide chambers with the chance to share their development of new ideas with their peers around the world.

## **Best Unconventional Project for SMEs**

Applicants will have developed an exceptional project in an activity not typically associated with a chamber of commerce. The project must be inspirational and innovative while demonstrating that it fulfilled specific needs and objectives of the chamber, serving its SME member community

#### **Best International Cooperation between Chambers**

Applicants will have developed an exceptional project that showcases how an international alliance between chambers can bring about important benefits to a chamber, its members, and/or the local economy.

#### **Best Skills Development Programme**

Education, training and seminars are a core service of many chambers of commerce.

Applicants will have developed an exceptional skill development programme that addressed

and fulfilled a niche in the changing education and information needs of their business community.

## **Best New Membership Recruitment Project**

Applicants will have developed an exceptional project that increased chamber membership by commendable, quantitative amounts. Submissions should highlight the project's unique attributes and emphasize the ways and incentives and/or fidelity programs that were used to attract and retain members. Public law (mandatory membership) chambers may apply in this category by highlighting any new fidelity or membership outreach projects.

## **Special Recognition Award**

# **Best Project from a Developing Country**

The World Chambers Competition Jury will automatically consider any eligible projects from the dossiers received for other categories of the competition for this award. This special award will recognize an exceptional project from within the group of applicants, demonstrating achievement and success in a challenging business environment.

#### **Finalists**

Judges have finished evaluating the entries for the 2007 World Chambers Competition and have announced the 20 finalists who have made it to the last round of the competition, which will take place in Istanbul in July.

All finalists will be invited to present their projects to the international judging panel at the Fifth World Chambers Congress in Istanbul from 4-6 July 2007.
